# Index Objective

The VettaFi Canada Extended Market Index Family is a float market cap weighted index family targeting 95% of the Canadian market. The capped sector indexes are sector indexes within the Canada Extended Market Index with an individual 25% constituent market cap.

# Highlights

Canada Extended Market Index: Targets 95% of the market cap of the Canadian Market

Capped Sector Indexes: Sectors are constructed using ICE classification standard with some sub-industry exclusions for the Energy sector.

#### Dates

Snapshot Dates: The last trading day of Feb and August.

Reconstitution Dates: Indexes reconstituted semi-annually on the third Friday of March and September.

Record Date: The close of trading on the day before the second Friday of the rebalancing month.

Rebalance Dates: Indexes are rebalanced quarterly on the third Friday of the last month of each calendar quarter.

# Index Construction

## Universe

Canada Extended Market Index: The starting universe consists of all Canadian equities that meet minimum market cap requirements. (see VettaFi Country Classification for Country Classifications)

Stocks with free float of less than 20% are excluded from the universe.

Certain pass-through securities, including REITS, Mortgage REITS, Master Limited Partnerships, Closed-End Funds and Business Development Companies are excluded.

Stocks must maintain a 90-day ADTV of at least 1 million USD or an R-Score of at least 1.0. The R-Score is calculated as follows: R-Score = 90-day ADTV (thousands USD) / Float Market Capitalization (millions USD)

Capped Sector Indexes: The cpped sector indexes use the Canada Extended Market Index as its universe.

#### Selection

Canada Extended Market Index: Targets a minimum market cap to cover 95% of the market cap of the Canadian market.

Capped Sector Indexes: Each sector index selects all constituents in its corresponding sector based on the ICE classification standard. The VettaFi Canada Energy Capped Index excludes the following sub-industries:

# Weighting

Stocks selected for inclusion are weighted based on their float market capitalization. Constituents in the sector indexes are capped at 25% with excess weight distributed pro rata to the remaining constituents. Share weights will be based on prices as of the "Record Date".

#### Rebalancing and Reconstitution

The Indexes are rebalanced on the "Rebalance Date" and additionally reconstituted on the "Reconstitution Date" using data as of the "Snapshot Date".

Pricing used in share weights used for reconstitutions are as of the "Record Date".

Share weights for the rebalanced Indexes are computed as of the "Record Date".

Changes to the Indexes related to the rebalances are as of the "Rebalance Date".

Additions are only made on "Reconstitution Dates".

#### Index Maintenance

Deletions are made at any time, in the event a stock is liquidated, de-listed, files for bankruptcy, is acquired, or merges with another stock.

The Market Cap Weighted Index Merger Approach 2.0 which considers the deal terms is used when the acquirer is a component stock of the index.
